

## OFFICIAL RULES

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.

1. **PROMOTION DESCRIPTION.** The **Vistas Giveaway** (the “**Sweepstakes**”) is open only to individuals working in the land management industry and begins 9/07/18 at 12:00:00 AM (CT) and ends 12/08/18 at 11:59:59 PM (CT) (“Promotion Period”). At the conclusion of the Promotion Period, one (1) grand-prize winner will be randomly selected by Dow AgroSciences LLC (“Sponsor”) or its designee, from all eligible entries received during the Promotion Period, as further described below. Entry into the Sweepstakes is free.
