



# SOUTHERN REWARDS TERMS AND CONDITIONS

1. Participating products will only be considered for rebate calculations if reported via electronic data exchange (EDI) or point of sale (POS) from an authorized PhytoGen® cottonseed dealer and invoiced between September 1, 2018, and August 31, 2019.
2. Purchases qualify only if they are invoiced and planted in the states or counties listed above.
3. Rebate payment will only be made on final net purchases (total purchases less replants and returns) that are used on the grower's owned or rented acres.
4. Replanted units claimed with PhytoGen® cottonseed will not be eligible for the Southern Rewards rebate.
5. Rebate payment will only be made to the party named on the invoice.
6. PhytoGen reserves the right to audit growers' purchases and use of PhytoGen products on their owned or rented acres.
7. All rebate information provided by PhytoGen regarding individual program earnings is a good faith estimate of total earnings potential. Actual total program earnings and payments will be calculated by PhytoGen at its sole discretion.
8. For seed containing insect-protection traits, grower must be in full compliance with all the IRM requirements relating to the product. Acres NOT in compliance will not qualify for rebate.
9. No purchases of seed containing licensed traits will qualify under this program unless the grower has signed a valid Technology Use Agreement with the technology provider(s) prior to planting.
10. Where permitted by law, PhytoGen reserves the right to deduct from program payments any amounts due to PhytoGen and/or Corteva Agriscience, Agriculture Division of DowDuPont.
11. PhytoGen reserves the right to modify or terminate this program at any time without notice. Participation by growers in this program is voluntary and is not required in order to purchase PhytoGen products.
12. PhytoGen will not issue a rebate check that is below \$250.00.
